- 7. Applications, amendments or cancellations of postal votes must reach the relevant Electoral Registration Officer by 5pm on Tuesday 19 April 2016.
- 8. Applications to vote by proxy at this election must reach the relevant Electoral Registration Officer by 5pm on Tuesday 26 April 2016.
- 9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer by 5pm on 5 May 2016. The physical incapacity must have occurred after 5pm on Tuesday 26 April 2016. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday 26 April 2016.
